

Sherborn Library Renovation Project Frequently Asked Questions

(Updated 11/1/16)



What is the latest on the Library renovation project?

The Sherborn Library renovation and expansion project is now moving at a rapid pace, with the final design having received necessary approvals and the construction documents having been made available to all interested bidders through a public municipal bid process. After all bids have been reviewed, the owner's project manager, Design Technique Inc., led by John Sayre-Scibona, and the project designers, Beacon Architectural Associates and Adams & Smith, will review the bids at a Library Building Committee (LBC) meeting in late November. The LBC will recommend the contract award to the Library Trustees, and the Town will award the library construction contract in December. The construction phase of the library project will then begin in late December. The Massachusetts Board of Library Commissioners continues to coordinate closely on the project to ensure the new library design meets requirements outlined in the original library grant application.

The project will fully renovate the existing 1971 Sherborn Library and thoughtfully expand this existing structure to include a new children's room, a multipurpose community room and an outdoor terrace connecting the new library to the rest of the town campus.

Will the Library relocate during construction?

During construction, the library will be relocated to the 'old schoolroom' on the first floor of the Sherborn Community Center. The Library Trustees are grateful to the Sherborn Community Center Foundation for making the space available. The Trustees anticipate relocation will take by mid-December, and currently expect that the renovated and expanded library will be ready to open to the public in late December 2017 or early January 2018.

How will we get rid of all the ‘stuff’ in the current building?

A clean-out of the Library has successfully removed nearly 50 years of ‘stuff’ from the attic eaves and the basement. A relocation team led by Library Building Committee member Libby Yon coordinated this effort, with support from library staff and Friends of the Sherborn Library. In anticipation of the reopening, library staff has also been carefully weeding our collection. The Friends have stopped accepting donations for the book bin. Surplus library materials and items that will no longer be needed will be disposed of according to municipal laws.

What can we expect during construction? Will the Town Campus be affected?

There will be some disruption to the Town Campus during construction. Trustees are working diligently to coordinate with the Unitarian Universalist Area Church, Pilgrim Church and the Council On Aging to mitigate disruption. In addition, Town Administrator David Williams will leverage monies appropriated at Town Meeting to study/assess construction vehicle access and staging areas and to ensure others have adequate access during construction. Trustees recognize that the process will be a disruption to library patrons as well as users of town hall and the police station, and are committed to a gold standard for communication to keep residents informed. Trustees also recognize that safety is of paramount consideration.

What is the latest budget? Do we have enough money to move forward?

The budget for the project is currently \$8.6 million – the construction marketplace in the northeast is extremely busy and has caused project estimates to rise. At this time, no additional money is being requested from taxpayers, as Trustees committed an additional \$1.2 million of endowment funds to cover the higher than estimated project cost when the increased cost was revealed back in December.

When will shovels go in the ground?

Construction documents have been made available to all interested bidders, general contractors and subcontractors through a municipal bid process. All bids will be opened later this month. After bids have been reviewed, the owner’s project manager, Design Technique Inc. led by John Sayre-Scibona, along with project designers, Beacon Architectural Associates and Adams & Smith, will review the bids at a Library Building Committee (LBC) meeting in late November. The LBC will recommend the contract award to the Library Trustees, and the Town will award the library construction contract in December. The construction phase of the library project will then begin in late December, with the renovated and expanded library ready to re-open late December 2017 or early January 2018.

The current renovation project represents an exciting and very real chapter in the library’s history: a direct result of visionary and deliberate planning. Since formalizing the contract for the \$3.6 million construction grant from the Massachusetts Board of Library Commissioners in September 2015, Library Trustees and the Library Building Committee have been working diligently to move the project forward. Design Technique, Inc. has been hired as Owner’s Project Manager and helped facilitate selection of Beacon Architectural Associates and Richard Smith as project designers.

How will Sherborn benefit from a renovated and expanded Library?

A key vision for the project is to create inspiring and functional space at the Sherborn Library for the whole community. The centerpiece of the project is a new wing, which will house a dedicated children’s room and adjacent outdoor garden and terrace. Below, a sun-filled community room with modern amenities will be available for groups in town to use for meetings, events and special functions. In addition, carefully designed exterior paths and walkways will provide easy access for all and will make the town campus more attractive and functional.

What is the overall project timeline?

- **April 2012** – MBLC places Sherborn on waitlist for \$3.6m grant
- **May 2012** – Trustees announce three-year capital campaign
- **September 2013** – Trustees launch public phase of capital campaign
- **October 2014** – Capital campaign raises \$3.8m in gifts and pledges
- **April 2015** – Town meeting votes to accept the anticipated MBLC grant, to accept privately raised funds and to approve the municipal portion of funding for the project; Trustees appoint Library Building Committee members
- **July 2015** – MBLC announces approval of \$3.6m construction grant awarded to Sherborn
- **October 2015** – Trustees present town with \$2.8m in private donations
- **January 2016** – Schematic Design Phase begins
- **March 2016** – Design Development Phase begins
- **October/December 2016** – Construction Bid and Award Phase
- **December 2016** – Library relocates to temporary location
- **December 2016** – Construction Phase begins
- **Late December 2017/January 2018** – Renovated library opens! (*anticipated*)

What is the scope of the project?

The current library structure will remain largely intact with significant renovation “behind the scenes” including up-to-date HVAC, code-required mechanical, electrical and emergency systems, a fire suppression system and energy efficient windows, which will be installed to gain LEED certification.

The most obvious element will be a new children’s room added to the rear of the building with a community hall, art gallery and conference room on the lower level accessible from the Town Hall parking lot. An elevator and separate egress will be situated between the original building and the new children’s wing. With the relocation of the children’s section, the original library will have greater space for new book displays, media and technology, adult-specific comfortable reading areas and improved staff workspace.

Upon completion of the renovation and expansion project, the entire library building will meet ADA standards and will be accessible to all.

How is the town paying for the project?

A combination of state, municipal and private money funds the project. In May 2012, Sherborn was placed on a wait list for a \$3.6 million grant from the MBLC. At that time, Trustees launched the quiet phase of the Campaign for the Sherborn Library to raise private funds to offset costs to the town. In fall 2013, the public phase of the campaign launched and successfully raised approximately \$3.8 million from more than 250 private donors. In July, 2015, the MBLC announced approval of the \$3.6 million construction grant for Sherborn. And in May, 2015, the town voted to commit \$1.0 million to the project.

In late 2015, a revised cost estimate for the project based on current market conditions exceeded the original budget due to greater than expected construction costs for both materials and labor. In response, Trustees conducted a thorough value engineering exercise to identify potential savings. Then, after careful consideration, Trustees voted unanimously to fund the necessary increases by contributing additional campaign funds and endowment monies.

This project is a model for Sherborn of a public-private partnership, with funding from state, municipal and private donor sources.

What will the Library look like after the project?
